The Role of the Federal Government in Public Education LWVUS Study with Consensus Questions

If your child moves from one part of the United States to another he will probably encounter substantial variations in graduation requirements. To address this problem, national **Common Core Standards** were developed by the National Governors' Association and the Council of Chief State School Officers in 2010. Forty states have adopted these standards and are aligning them to state standards. These standards are not a federal government mandate, even though acceptance of the standards was a requirement to qualify for "Race to the Top" funding. Now the question is how these standards should relate to national programs.

Leagues across the country are studying common core standards, assessments, and issues of equity and funding in order to develop a position that will be the basis for LWVUS action on the role of the federal government in public education. **Consensus questions are on pages 5-6. Bring them to the meeting.** While we will address each question, consensus is not so much a vote, but rather is the sense of the meeting. As you can see, there are a lot of questions, so we plan to have a second session on Monday, November 14th, to complete the Consensus.

Grace Kachaturoff and Barbara Rosalik are chairing LWVOA's education committee.

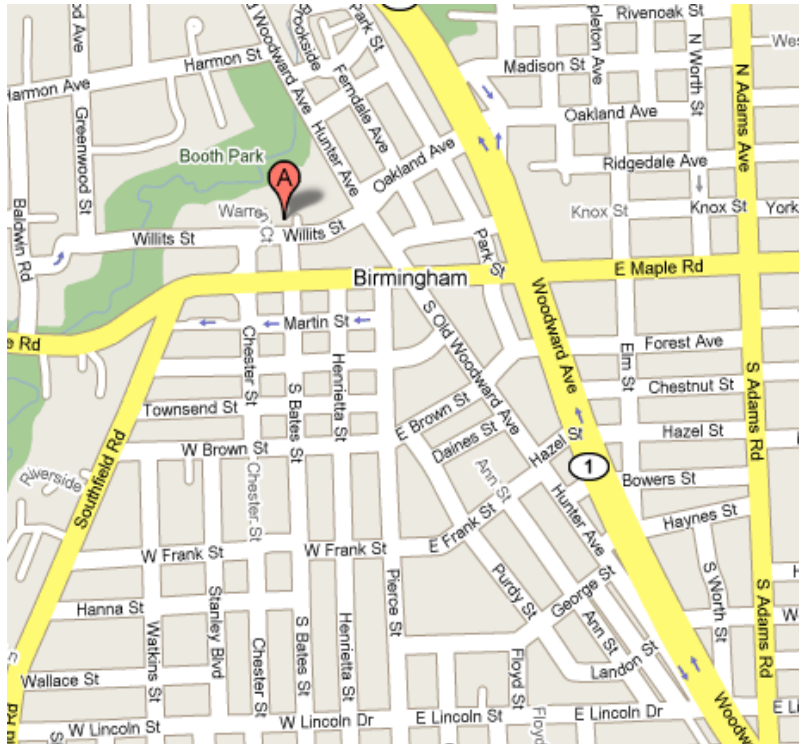

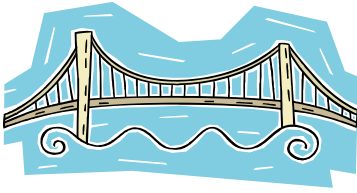

LWV Detroit Metro Area hosts speakers on proposed New International Trade Crossing



On June 25th, the League of Women Voters Detroit Metropolitan Area, an Inter-League Organization for the tri-county area, held its Annual Meeting at Fortesa Restaurant in Rochester. Delegates approved the proposed budget for 2011-2012 and re-adopted DMA positions on Transportation, Housing, and Waste Treatment / River Basins. Officers elected were: President Mary Bugeia, 1st Vice-president Eboni LaMar, Secretary Barbara Suhay, and Directors Fran Schonenberg and Karen DeGrendel. Elected to the Nominating Committee were Mary Ann Barkach as Chair and Barbara Adams as a member.

After a delicious lunch, President Mary Bugeia introduced the speakers on the New International Trade Crossing (NITC):
- **Mickey Blashfield, Director, Governmental Affairs for the Ambassador Bridge, who spoke against NITC**
- **Tom Shields, President, Marketing Resource Group, who spoke in favor of NITC.**

Blashfield spoke in favor of building an additional span at the privately-owned (by Matty Maroun) Ambassador Bridge which requires no action by the legislature and no cost to taxpayers. He said traffic went down from 1999 to 2009 as auto plants were closed and, therefore, the new bridge further downriver is not needed. It would take business from the existing bridge. Custom booths have doubled at the current bridge and pre-screening is used to reduce backups. He said costs incurred by Ambassador Bridge to twin its span would also qualify for government matching funds for roads. He noted that the I-75 Gateway Project just completed was designed to handle a second span at Ambassador Bridge and pointed out that the NITC location is over salt mines.

Shields represented the broad coalition of businesses big and small from all over the state that support NITC. He noted that all past and present Governors, Brooks Patterson, Wayne County, Detroit and labor unions support NITC. Canada is the US's #1 trade partner both ways, representing 49% of U.S. exports and 7 million jobs, including 237,000 in Michigan. 1/3 of that traffic goes over the Ambassador Bridge. Tie-ups due to the 7 miles and 18 traffic lights to Canadian highway 401 cost US businesses millions. Michigan agriculture is a big and growing exporter to Canada. Truck traffic is projected to double by 2035 plus post-9/11 security takes more time. The Ambassador Bridge has no approvals on either side of the border. Canada has been adamant that they cannot handle any more traffic at the current location in Windsor.

Regarding funding, Canada has offered \$550 million for Michigan's costs for its share of the roadwork and new plaza to be built and has committed to pick up any overruns if needed. Legislation is needed not for funding, but to create an authority to work with Canada. The bridge itself will be bid out to a private developer to build, operate and maintain. NITC will bring 10,000 jobs for Michigan and 20,000 for Canada. The \$550 million leverages \$2.2 billion in US road funds and will help jumpstart the economy. A second bridge separate from the existing one is needed for security and safety reasons and will provide freeway-to-freeway access and expandable plazas. By comparison to Detroit, Buffalo has 4 bridges and 14 lanes vs. our one bridge. Truck traffic cannot use the tunnel.
