- Or at any Secretary of State driver's license office.
- Or at offices of Family Independence Agency, Dept. of Community Health, and Michigan Job Commission,
- Or at military recruitment centers.

### YOU MAY VOTE IF YOU ARE:

- a citizen of the United States, and
  - 18 years of age by the date of election, and
  - a resident of the community for 30 days, and
  - registered to vote 30 days or more prior to the election.
- Unless you move, you do not need to re-register.
